CORPORATE OVERVIEW

Ahtna Diversified Holdings, LLC (ADH) is a holding company for seven subsidiaries within the Ahtna, Inc., (AI) Family of Companies. AI is an ANC and ADH has ANC 8(a) and Small Disadvantaged Business contracting capabilities. The common management of these subsidiaries is in accordance with SBA guidelines and associated federal regulations (48 CFR 15.305 – Proposal Evaluation).

Ahtna has more than 400 staff in 14 strategic offices throughout the US. Ahtna has implemented innovative technologies for groundwater extraction and treatment systems using novel ion exchange regenerable resin technology. Ahtna has used these treatment technologies to prevent further impacts to drinking water from groundwater impacted by PFAS.
