Ahtna Diversified Holdings, LLC (ADH) is a holding company for seven subsidiaries within the Ahtna, Inc., (AI) Family of Companies. AI is an Alaska Native Regional Corporation (ANC) and ADH has ANC 8(a) and Small Disadvantaged Business contracting capabilities focused on the environmental, construction, and professional services sectors. The common management of these subsidiaries is in accordance with SBA guidelines and associated federal regulations (48 CFR 15.305 – Proposal Evaluation).

ADH has nearly 400 staff in 12 strategic offices offering a nationwide coverage with a global reach. Our experienced staff has a proven track record in successfully completing projects in the most challenging environments all while maintaining an excellent safety record with an OSHA Experience Modification Rate of 0.70.

We routinely mobilize to sites using chartered barges, landing crafts, fixed wing aircraft, and helicopters.
